Hello, my name is **Gary Walters**, starting next week Amazon will be publishing my Book co-authored with me is Ross Huebner.

The reason why I am contacting you is because my friend Micheal McDonald met some of you here in Vegas last week ,and encouraged me to contact you to see if there may be an interest is either making a documentary or Film based upon a real true story in modern times.

The Story

I was sent to prison when I was 55 years old for paper crimes that I did not commit. I and was given a death sentence of 28 to 64 years for real estate forgery and related charges. I had my identity stolen by a group of grifters here in Nevada involved in a huge Real Estate and HOA scam. This scam involved money being funneled into Bank of America of the by the late Phillipian President Fernand Marcos, whose money and was being used to build and sell high end mansions.

The Judge Micheal P. Vallani denied all my witnesses and witness briefs, excluding my hand writing expert, and forced me in front of an innocent and deliberately blinded jury, which was not allowed to hear my 26 witnesses and handwriting expert Claudia Antonio Baker. The judge ordered the denial of my witnesses because my criminal defense attorney, Robert Weatherford, failed to file a witness list which is required for witnesses to appear for my defense. My attorney failed to interview and prepare any of my witnesses and failed to prepare for my trial. Unbeknownst to me my attorney was being prosecuted by the District Attorney's office at the same time DUI drugs, a gun and a bag of meth. At no time was I ever informed that my attorney had his own legal case going on. Consequently, my attorney ultimately wound up in my old bunk in Southern Desert Correctional Center - a Nevada Prison. Judge Kathy Hardcastle sentenced my criminal attorney to 2 to 5 years after he continued to drink and drive and do drugs.

When my case came to trial and I found out that Because my attorney was completely unprepared, I attempted to exercise my right to represent myself and Judge Vallani

denied me a ***Farretta v. California*** hearing, which would allow me to represent myself. Instead, Judge Vallani forced my attorney on me. I went to trial with both hands tied behind my back and wearing an unseen gag. I did not want to go to trial, but because my attorney surprised me with the revelation that I had no expert witness and all of my other witnesses were being denied.

My expert witness was not only going to testify that I did not commit these paper crimes, but was going to tell the court exactly who did. I would have been unequivocally found innocent. But because I had no witnesses in my favor, the jury received no evidence showing my innocence. While the jury was out, I left the court house with my attorney. My attorney told me that the jury came back and the judge's chambers had called him and that the jury came back with a guilty plea. My attorney told me that the Judge had ordered an arrest warrant for me and it was a shoot to kill order. My attorney told me to run.

I appeared for sentencing, where Judge Vallani stated "Before I announce Judgement have you anything to say for yourself?" I said "Your honor I am innocent and you are about to embark on the biggest mistake of your judicial career, sending me to prison for something that I did not do," Following my statement, Judge Vallani pronounced judgement on me and gave me the equivalent of a death sentence.

After I got out of the "fish tank" at Southern Desert Nevada which took ,45 days, I was transported to a minimum security prison at Southern Desert Correctional facility just down the road from High Desert Maximum facility.

The Lord Blessed me with having the ability to read, comprehension and understand laws. While in the prison spent every minute available in the law library working on getting my case reversed. I read over 3,000 cases and then I read a passage in the bible whereby Peter was thrown into prison and the Lord came to Peter in prison. Peter proclaimed to the Lord that he was not worthy of the Lord coming and visiting him in prison, and the Lord said to Peter, "Do you not know why I visited you in prison? I did so because you were helping other prisoners." This story resonated with me and as a result of that passage, I set about helping other prisoners without charging them for my help. As a result, I was able to help free over 200 Inmates. There were times when I returned to my bunk and there were bags of groceries on my bunk. Because of my helping other prisoners, regardless of their race or charges, I became the only white person in prison that could sit with all the races and eat with them, without being killed. While I worked on my case, I applied for a job on the yard as a PI Auto clerk, which is one of the top paying jobs on the yard and I got hired. At that time, I was only on the yard for only 4 months and getting a top paying job clearing 251.00 dollars every 2 weeks was the highest paying job in prison and certainly the Lord's blessing.

While working as a PI Auto clerk I was able to use the prisons computers and was able to type my Writs and filings with the Nevada Supreme Court requesting an En Banc hearing and reconsideration, where all the justices would have to hear my case. Only 0.05 percent of cases gets a reversal once the Nevada Supreme Court affirms their conviction, the Lord Blessed me with a reversal and remanded my case to District Court.

They appointed me a former Deputy District attorney named Joshua Tomcheck, who was appointed as an outside contract public defender. Mr. Tomcheck, informed the Court that my case was complicated and he took me off calendar for another 5 years claiming my case. For representing me Mr. Tomcheck charged the State over \$100,000.00, but essentially did nothing for 5 years.

I helped other inmates who were illiterate and could not read or understand law, I filed the required AR 714 forms with the law library to help people with the filings of their Post Conviction Habeas Corpus, in their attempts to overcome the State's claims of procedural time bars. Habeas Corpus filings are required to be filed within one year. The prison makes it very difficult to meet this time bar by limiting access to the Law Library. However, there is an exception where you can allege "Actual Innocence." My work resulted in new trials and releases for over 200 inmates. One day, Willie, doing time for a child molesting charge who worked in the tool room of the PI Auto Clerk told the civilian staff that I was doing my legal work on their computers. Luckily I had just got my filings done and sent to the Nevada Supreme Court.

When I took that Job as the PI Auto Clerk, the company was a negative 500 thousand dollars in the Red. I also reorganized their inventory was able to put them 100 thousand dollars in the black and developed an amortization plan for the PI Auto shop. Willie reported me for using the company computer for my legal work and I was lucky that Craig Coastguard, the PI Auto prison industry called me into his office and said to me, "Walters I am going to have to fire you, because I cannot compromise with you, otherwise it will be all over the yard and we cannot have that." Mr. Coastguard went on to say, "Walters I am not going to write you up because you saved a lot of jobs in here, had it not been for you." Then he stated, "I will not write you up, so in six months perhaps I can then hire you back." I thank him for his lenity and told him, "Sir, but I will not be here in 6 months, I know the Lord is going to bless me." Mr. Coastguard laughed at me and said, "That's what they all say Walters." I told to him that's ok.

From that point forward I was able to start the work of helping other inmates, then the squad of CO's came to the dorms and said, "Walters roll up, Warden Williams said to come and get you and take you to the hole." I asked them, "Why am I going to the hole [solitary confinement]?" The CO's said, "The Warden says your practicing law without a license." I told them, "I have an AR 714 on file and approved by the law library manager." They said, "Take it up with the warden." After they hooked me up, they took everything I had a TV and other appliances, my bed Linens and clothes. They took it all and put them in the inventory room lock up.

I had no pillows, no a blanket and no mattress. I had to sleep on an empty metal bunk. But as if this was bad enough, the worse part was in the winter time they turn the air conditioning on and it is bone chilling cold, even freezing. In order to keep warm I had to sleep in the fetal position. In the summer they turned off the air conditioning and turned on the heat. I was in the hole for two years for helping other inmates with their legal paperwork. I found myself praying to the Lord to help me. The Lord did answer some of my prayers, because the Lord said to me Walters I will not encourage you to tell a lie, that

call is left up to you, however, the Lord said to me, but I will not abandon you and will show you a way.

The next morning I heard the Correctional Officer delivering breakfast to inmates to serve them their trays of food and in the next cell I saw a Jewish guy receiving what I learned was called Kosher food that was actually blessed by a Rabbi and consisted of “real food.” As my heritage was German-Jew and Tennessean, I decided to take advantage of this program. I saw that the Jewish inmate next to me was trading his kosher food for legal work. Although I had not been a practicing Jew, the Jewish inmate helped me study for the religious test. I sent a kite to the Chaplain and informed him my religious rights were being violated. I took the religious test and I passed it.

I begin receiving the kosher food and I used this “real” food, consisting of starkest tuna and bananas, onions, whole tomatoes, etc, and to trade them for case law to be delivered to me in the hole. Then after receiving the case law, something extraordinary hit me like a ton of bricks. I read the case of ***Gideon v. Wainwright***. Gideon was an illiterate inmate doing time in a Florida prison and his new cell mate was an attorney, who was imprisoned for murdering his wife and a judge, who he caught having an affair together. Gideon’s bunkmate taught him how to read and write, how to read and understand case law, and as a result of Gideon’s work and calling, he caused to be freed up over 4,500 inmates in Florida prisons some received new trials and others were released from prison.

Once I read the Gideon case, it inspired me to do in depth research and I found the potential that the Lord must of have a plan for me. My calling revealed itself in that my research revealed that the Nevada Revised Statutes are all Void Ab Initio. Because of this these statutes all constitutionally fail and that over 11,000 inmates regardless of crimes are being held against their will, because if you have laws that have not been lawfully and constitutionally been passed. When the court lacks subject matter jurisdiction, they do not have the authority to act.

I set about getting the documents necessary to prove up the finding that the Nevada Revised Statutes were fraudulently passed and therefore not law. So I took the money that I earned from my previous prison Job and brass slipped the money out to a friend named Morton Friedberg, a short 4 foot 6 inch tall Jewish man, who wore a Yamilka and had him rent a car, drive to Carson City and Reno, Nevada and meet a whistle blower who provided me with the documents that I needed. These documents showed that in 1951 the Nevada Revised Statutes were hijacked by conspirators who transferred them to the Legislative Counsel Bureau, a dark shadow non-government entity that exists to this day. These Legislative Records were moved to the LCB, a private non-government entity, who is exempt from subpoenas and discovery requests. In other words, the dark powers that be in Nevada took their error and hid it in the LCB where the unconstitutionality of it could not be discovered and proven. So the transfer to the LCB violated the Nevada Constitution because the Nevada Constitution holds that the repository of all Legislative and Executive records are to be deposited and protected by the Secretary of State, who has a constitutional responsibility to maintain them and provide them to the public at their request.

That these documents have been deliberately hidden by these Tyrants of Tyranny. We realized that I was on the verge of the greatest legal find in Nevada history. So we now have uncovered the stealth Fraud and ongoing Long Arm Fraud that exists still today. A book has now been written about this legal discovery. The book will be out next week and although it only focuses on the Nevada Revised Statutes being illegal and the exposing of the he dark shadow nongovernment controlling all the money for years operating as a criminal enterprise. My story will be told in another book so that it does not take away from the incredible discovery.

The Lord is my Shepard and I shall not want, the Lord guided my hand in freeing up over 200 prisoners who did not belong in prison and were falsely accused. The prisoner are treated horrifically in the Nevada Prisons where they are feed food that causes diabetes and the boxes are labeled "Not For Human Consumption." These men go to bed hungry ever night and unless you have a financial support group that can allow an inmate to buy the junk food in the commissary they just have to suffer. This is truly shameful and worthy of telling the story.

One person named Fred Niece, whose prison nickname was shaggy, he had served 28 years on a murder charge that he did not commit. When I became his cell mate and found he was totally innocent of a crime for which he was given a life sentence without the possibility of parole. Shaggy's conviction was only made possible by crooked District Attorneys who hid the exculpatory evidence. The District Attorney and Judge allowed the state to suppress Shaggy's evidence consisting of a video showing Shaggy was at the train station in Philadelphia and had a time and date stamped ticket for the day of the murder. They convicted him anyway. Case closed. Shaggy was released from prison after almost 30 years.

Since I have now been out for 6 years, I have been able to mass billions of dollars in mining assets and right now I am in various negotiations to sell, JV and/or trade these valuable resources into very large sums of cash. Before I went to prison, I was a multimillionaire with 33 exotic vehicles, which were all stolen and sold after forging my signature on the titles. I also had 4 mansions and 4 condos, as well as an art collection. Also had controlling stock in 6 publicly traded companies. All of these were stolen and sold by people who said that they were my friends. There is an old biblical saying that "When God means to make a man great, he breaks him to pieces first." God did this with Saul, a man who persecuted the Christians, who became Paul. One of his greatest disciples.

The Lord has provided me with the path of Job. I have tried to make the best of what the Lord has blessed me with and believed that my glass is half-full, not half-empty. I saw the Sound of Freedom when it first came out and I would like to assist in the stopping of the exploitation of children and stop the trafficking going on in Puerto Rico and other places. I would like to meet with someone as soon as possible and share this opportunity that God has provided to advance our common goals. The Tyrants of Tyranny and all the exhibits and proof will expose these Tyrants and all of the discovered illegal activity. We

are urging that the government further investigate because we believe that they will find an entire criminal enterprise going on right under everybody's nose.
